  - Fonts:
    - Type and size. We provide a browser based subscription service which allows users to customize the zoom level of the text.
    - Colors and background colors can be adjusted. We provide a browser based subscription service which allows users to customize settings using their browser.
  - Background: High contrast color settings are available. We provide a browser based subscription service which allows users to customize settings using their browser.
  - Text-to-speech tools TCI has a text-to-speech option for all Student Subscriptions in both English and Spanish
  - All images have alt tags. TCI does not currently provide alt tags.
  - All videos are captioned. We provide transcripts for all TCI videos upon request.
    - Text, image tags, and captioning sent to refreshable Braille displays. We provide a browser based subscription service which allows users to access content as allowed by their browser.
2. How are the following **navigation features** provided in the instructional materials:
  - Non-text navigation elements (buttons, icons, etc.) can be adjusted in size. We provide a browser based subscription service which allows users to customize the zoom.
  - All navigation elements and menu items have keyboard shortcuts. We provide a browser based subscription service which allows users to customize settings using their browser.
  - All navigation information can be sent to refreshable Braille displays. We provide a browser based subscription service which allows users to access content as allowed by their browser.
3. How are the following **study tools** provided in the instructional materials:
  - Highlighters are provided in the four standard colors (yellow, rose, green, blue). TCI does not currently provide four standard color highlighters.
  - Highlighted text can be automatically extracted into another document. TCI does not currently provide an automatic extract of content, but students have the capability to copy and paste content into another document.

- Note taking tools are available for students to write ideas online; as they are processing curriculum content. The Student Subscription provides online note taking tools.

4. Which of the following **assistive technology supports, by product name**, have you tested for use with the instructional materials:

- Assistive technology software that can be run in the background. Examples include:
